The financial crisis takes his run - The end of capitalism in sight

For over three decades, I am dealing with capitalism as religion and government, now increasingly dominating since five hundred years the thought of our Western society. This ideology now dominates and determines the governments and the policy of all countries, and therefore begins to destroy itself. The increasingly powerful large capacity computers of our young information technology have played a big part. In the short time since these electronic devices are available, man cannot get used to the pace of this technology, because their computing capacity doubled their speed almost each year. Therefore, to look over these processes and relationships only a few very alert contemporaries with enough distance are capable.

I am convinced that within the next two years our entire financial system will collapse, or at least will need a radical change. In parallel, many new solidarity movements will arise. Our entire monetary system must change if we want to continue to use money as a medium of exchange. The very simple compound interest calculation would require every citizen who thinks about it, the leading robber mentality of the financial industry in mind (equity-yield of 15-25%), but strangely enough, many mathematically gifted people express difficulty on that issue. This aspect shows the efficacy of these faith-ideology (ZKB - local Swiss bank - slogan: "Your money works for you!"

If we can read in the newspaper that high frequency trading is currently constitutes 70% of the entire global financial trade, I ask myself whether all politicians are already blinded by sheer lust for power. If our economy wants to survive the current financial crisis caused of the banks, policy measures have to be taken to prohibit the banking business in its current form with their virtual products. The personal consequences

Out of exactly these contexts I and my three brothers decided together with our co-heirs of the families Todesco to sell the business- and multifamily house that was built in 1938 of our parents and relatives on the Zürichstrasse 9 in Uster. We now have another two years time, and can manage the house at this time and continue to inhabit on our own and previous conditions. The sales contract is signed and when the money system is not completely broken, and therefore our buyers could no longer pay, the handover will be on 30 September 2013.

That means for me house-hunting and reorientation. My <u>course</u> starting from October 2013 can no longer be hold on the present address, the Zürichstrasse 9 in Uster, but must be offered at another location. I am therefore very interested in corresponding offers both an apartment with a rent of CHF 1000 to 1500 and in affordable meeting facilities for my course.

Today negative forces increasingly desperate try to defend themselves to survive, so it should not surprise us that this transition cannot take place peacefully. With my range of information and with my course I try to do my part to help make this transition more smoothly and profitably for all.
